Terms and Conditions of this stallion contract

- 1.The mare is booked specifically by name. The booking is valid to the mare named and may not be transferred without consent of Mac Lilley Farms Ltd.
- 2.Mare owner agrees that the mare named in this application shall be healthy and in sound breeding condition. The mare must be registered.
- 3.Neither Mac Lilley Farms Ltd. It's owners, principals, employees, or agents shall be liable or responsible for any injury, disability, or death suffered by any mare, or her offspring, from any cause whatsoever, while in the care, custody, or control of Mac Lilley Farms Ltd. The undersigned owner specifically agrees to this condition and hereby waves and releases all and every claim for damages resulting from such injury, disability or death.
- 4.The service fee shall be due when the mare produces a live foal that can stand up alone and nurse, or when the mare changes ownership, whichever occurs first.

The Harmonized sales tax (HST) (13%) will be applicable to service fees, board billings, and veterinary charges, etc. and it will be added to all invoices. Mac Lilley Farms Ltd. HST# is R103440186. If the stud fee is not paid within 30 days of foaling a 1.5% monthly service charge will apply.

5. All accounts for board, service fee (if due) overdue interest and expenditures made on the mare (and /or her foal) will be settled upon receipt of duly rendered invoices and in any event before the mare is removed from the farm.

6. The mare must have a negative coggins test for equine infectious anemia dated no earlier than 24 months prior to date of her arrival at the farm. A certificate to this effect must accompany the mare upon her arrival to the farm. Mac Lilley Farms Ltd. Reserves the right to re-test the mare upon arrival at owner's expense.

7. Semen transport is available with prior notification and approval from Mac Lilley Farms Ltd. Please note that a valid, Fed Ex number and credit card are mandatory before booking semen shipments.

8. If one owner signs this agreement, when there are multiple owners, the terms and conditions of this agreement will bind all owners.

9. We encourage you to phone or email your semen order by 8:00am on the day you will be needing semen.
